Hola Amig@s,

As I look back on the year, I am filled with hope. Certainly, the challenges facing Latinas and our Latin@ communities were many - the COVID pandemic continues to disproportionately hurt us, anti-immigrant sentiment is rising, and the Supreme Court ended constitutionally guaranteed abortion rights in a decision guaranteed to be devastating for survivors.

But in this year, Esperanza United celebrated our 40th anniversary. For four decades we have had the privilege of listening to, learning from, and serving Latina survivors in the Twin Cities. In 2004, we began expanding our work nationally.

This year, our work has expanded again thanks to historic support from the federal government. We are now working to improve the healthcare system, partnering with Mobile Health Units and promotoras across the nation to ensure our community has a voice in the ways survivors are served. We also grew our grant-making activities, selecting 28 amazing organizations to receive \$12 million in federal funds to support Latina and Hispanic culturally specific, community-based organizations and survivors of domestic violence and sexual assault. And we nurtured the next generation of policy and research leaders through our Latina Leaderships fellowship.

In our home of St. Paul, we housed 77 individuals at our shelter, El Refugio, providing 34 families with a safe, supportive place to heal and grow. On top of that, we provided intensive advocacy to 197 adult participants and resources and referrals to 339 additional community members. We reached them where they are, running prevention programs in local schools, community centers, and government agencies. In fact, we attended 25 local events, engaging at least 750 Latin@ community members.

The Esperanza United team also continues to make me proud - whether that's Engaging Boys & Men Specialist Felix Martinez being named to the Youth Worker Hall of Fame or our former Senior Director of Public Policy Rosie Hidalgo becoming the first Latina to head the Office on Violence Against Women - our team is impressive.

Every day, I am inspired by our youth leaders working to make a difference, survivors building families free from violence, and the service providers who generate hope, often out of tiny budgets and in hostile environments. Together, these community members and their allies are planting the seeds of hope, for survivors, for Latin@s, for us all.

It is because of them, because of you, because of all of us, that I am filled with hope. Please read on to find out more about accomplishments in fiscal year 2023.

Family **ADVOCACY**

Esperanza United provides family advocacy to the Latin@ communities in the sevencounty metropolitan area of the Twin Cities, Minnesota, meeting survivors where they are. This fiscal year, we focused on supporting Latin@ survivors and their families through their whole journeys by building out our services to provide better legal support and more human trafficking intervention, partnering with diverse organizations from the Mexican Consulate to Caminatas Dominguera, and organizing community events such as the annual Mujeres Latinas Expo and our Dia de los Muertos celebration.

Prevention and **SOCIAL CHANGE**

Esperanza United works with the entire community to prevent gender-based violence, using a whole-family approach. This fiscal year, we were happy to invest in our in-person work - hosting family events such as canoeing and a soccer tournament, a girls' overnight camp, healthy masculinity workshops, and in-school programming - while working with youth leaders to host their annual conference in a virtual platform where participants could create their avatar to explore the conference "space" including the presentation rooms, a self-care garden filled with resources for the youth, and a games room made to socialize.

Training and TECHNICAL ASSISTANCE

Esperanza United increases the capacity of government and community-based organizations to deliver culturally responsive and trauma-informed approaches to Latin@ survivors. This fiscal year, we were proud to convene our community at ¡Adelante¡ A virtual celebration of Latin@-led advocacy, partner with mobile health units and promotoras to increase the healthcare system's responsiveness to Latin@ survivors, launch a new toolkit on enhancing survivors' court access, conduct listening session across the country and in the territory of Puerto Rico, and form our first training and technical assistance advisory board comprised of diverse Latin@ leaders



across the country.

Reseach and **EVALUATION**

Esperanza United elevates the voices and realities of Latin@ communities through research and evaluation that promotes social justice in the field of domestic violence and sexual assault. This fiscal year, we grew our impact by publishing a case study of a national Photovoice study in the American Journal of Community Psychology, a high-impact peer-reviewed academic journal. The first and second cohorts of the Research and Policy Latina Leadership Fellowship completed training and mentored projects. And we developed a hotline survey and needs assessment survey in collaboration with our partners at the Domestic Violence Resource Network.

Esperanza United works to ensure that policies nationwide are responsive to the needs and realities of Latin@ communities. This fiscal year, we advocated for more funds for survivor services through the appropriations process; attended the signing ceremony at the White House for the Bipartisan Safer for Communities Act (BSCA), which moves closer to closing the "boyfriend loophole;" and worked on increasing immigrant rights by addressing issues like Title 42, the public charge rule, and training the staff of the newly formed HART Center. We also participated in coalition for activations such as Latina Equal Pay Day and hosted our second class of Latina policy


